Welcome to the 2025 Heart of New Mexico Fiber and Art Gathering! Held one weekend every year at Wildlife West Nature and Rescue Park in Edgewood, NM. Our Fall event will continue as in the past and will be held over Labor Day weekend, August 30<sup>th</sup> & 31st. The Fall Gathering is held in conjunction with the Wildlife Rescue Park in Edgewood, New Mexico. Our proceeds, after expenses, will be donated to Wildlife West.

### Hours for both events will be:

10:00am – 5:00pm on Saturday. 10:00am – 4:00pm on Sunday \*Set up Friday from 12:00 noon until 5:00pm \*Break down **after** 4:00pm on Sunday \*Monday hours TBD

**Purpose:** Our purpose is to promote natural fibers and related industries by providing a marketplace for both fiber animal and other natural fibers/products, and the products and equipment used in the industry. Along with other handcrafted arts and goods-i.e. pottery, jewelry and woodworking as defined in the guidelines.

# Booth fees for each festival:

10'x10' booth space: \$50.00 8'x8' fiber animal pen \$40.00 10'x20' booth space: \$90.00 8x16 fiber animal pen \$75.00 (If doing a booth/pen combo there is a \$10 discount)

# **Deadlines/Timeline:**

7/1/25 - Applications and photos Deadline for Fall 2025.

**Process is as follows:** 

Jury process will begin approximately on the 10<sup>th</sup> of July.

Applications should be emailed to

vendor.HONM.Gathering@gmail.com, no mailed in applications will be accepted. Fees are not due at the time your application is sent in. Once vendor has been accepted you will receive an invoice via email with an invoice attached which is payable by check or square (if necessary other arrangements can be made on a case by case basis). Payment is due within one week of invoice being sent. \*Acceptance letters including the invoice will be emailed out by mid month after the jury process has been completed. PLEASE make sure your email address is legible!

**Jury Process:** The Gathering Jury Committee considers the quality of products being sold as top priority. Each application will be viewed with an eye to quality and uniqueness. **All items must be vendors original artwork and handcrafted. Items may be disqualified if found not to meet the above guidelines.** They will consider the applicant's state of residency. Priority will be given to qualified applicants within our region (New Mexico, Colorado, Texas and Arizona). Also to be considered and priority given to the use of regional (first) and domestic (second) fibers used.

# Guidelines

- 1. All items in your booth must comply with the Gatherings stated purpose. We encourage your use of regional and domestic fibers. An exception will be silk which may be purchased internationally. All fiber used must be of animal or plant origin (example: wool and cotton). Synthetic fibers may be used but should only be used to enhance the natural fiber and not be the majority of the finished product.
- 2. In keeping with our handcrafted intent of this show we discourage the use of machinery i.e. embroidery machine, laser printer, etc. However, 30% of the craftsman process may be assisted by machinery or computers.

\*\*These regulations are in effect as of 2025. Those prior vendors are grandfathered in as set forth in previous guidelines.

- 3. Consignments are allowed but consignees must go through the same application and jury process as vendors and meet all stated deadlines. No exceptions.
- 4. Only one 10'x10' or 10'x20' space will be provided unless additional spaces are purchased for an additional \$50.00 or \$90.00 (whichever

is applicable) per space. Electricity is not provided. Gravel pathways must remain clear to be wheelchair accessible to the public. Vendors are responsible for trash in and around your booth. Booths must stay open until the closing of the Gathering on Sunday.

- 5. The Gathering reserves the right to remove a vendor for violations of the guidelines or item for sale that do not comply with the guidelines.
- 6. Cancellations: If you need to cancel you must submit, in writing, your need to cancel 30 days before the Gathering. 80% of your booth fee will be refunded. If the event is canceled by Heart of NM Fiber and Art Gathering, due to circumstances out of our control, there are two options: 1) 75% of booth fees will be refunded or 2)fee applied toward the next event.
- 7. Weather may be an issue, so all tents **MUST** be staked securely down. It is **STRONGLY** recommended that you weight your tent down using 40 pound weights at each corner. Neither the Gathering or Wildlife West will be responsible for any damage due to the weather to your tent or contents.
- 8. Vendors agree that the Heart of New Mexico Fiber and Art Gathering and Wildlife West Nature and Rescue Park and its agents shall not be liable for any loss, damage or injury to any person, property or animals which is caused directly or indirectly for any reason in or upon the grounds/site which they shall be part of or adjoining areas. Vendor also agrees to hold harmless the Heart of New Mexico Fiber and Art Gathering, Wildlife West Nature and Wildlife Rescue Park, or the town of Edgewood, New Mexico for any expenses or liabilities, including attorney fees.
- 9. Dogs are allowed only in the event area and must be leashed or contained at all times.
